I further agree to defend, indemnify and hold harmless Event Organizers from and against any and all personal injuries, damages, losses, causes of action, liabilities and expenses resulting or which may result from my participation in the Event on 8/11/2018 and/or the condition of the raceway, property, facilities or equipment used for the Event.
